

CALL TO ORDER: Mayor Briffa called the meeting to order at 6:30 pm followed by the Pledge of Allegiance.

<u>MINUTES</u>: The minutes of the October 21, 2019 Board Meeting were accepted as corrected on a motion by Trustee Rizzo, 2nd by Trustee Constantino [Motion Carried 3-0]

COMMITTEE REPORTS:

Fire Company Report:

Fire Chief Jim Kane reported the following:

- The department was called out 6 times with 62 calls YTD (See attached report)
- 2) FEMA Grant was denied.
- 3) Master intake valve on P134 has issues & needs repair.
- 4) Smoke Alarm Campaign is underway. There was clarification that local Leicester Fire Department personnel will be doing the installs not the Red Cross as was misunderstood by a resident.

Highway Superintendent Report:

Highway Superintendent Russ Page reported the following:

- Leaf Pick-Up: Two leaf pick-ups have been done. Last pick-up delayed due to weather. May have to use loader to pick up piles we have or wait until Spring. Leaf Vac needs repair and part has been ordered.
 Sheriff Work Release Program delayed due to weather and is dependent on weather. If they come, they will concentrate on gazebo area and around school as they only have 2 people in the program.
- Will be covering water for Al Nov 25 Dec 6
- 3) Jones Bridge Drainage is weather dependent this season.
- 4) Snow Plowing: Due to Town staff changes, Russ will no longer be plowing and a part-time employee will be plowing the Village leading to extra non-budgeted expenses for the Village.

Water Report:

Water Operator Al Mothershed reported the following:

1) Route 36 Water Main Replacement: Trustee Constantino motioned, 2rd by Trustee Jacobs to approve the engineering quote from MRB for \$41,668.00 for meter pit replacement to connect lines and properly drain. [Motion carried 3-0] The job will need to go out for bid.

- 2) Hydrant Issues: Hydrants have been flushed. Hydrants on Penny Lane & North Street will need to be rechecked in the Spring and 2 need extensions because they are too short. Mayor Briffa asked for a list of all hydrant locations.
- 3) Annual Audit: Upon completion it was noted that Al's license grade is in question and will be researched; the pump house generator is still requested; it is requested the Village inspect the pump at the Ratchford residence; the Mt. Morris treatment plant is not making any changes until funding is received so no changes are expected in water quality for the Village
- 4) Mayor Briffa asked Al to work on a Comprehensive Plan outlying the projects; ie. Pleasant Street then South Parkway, etc

Zoning/Code Enforcement Report:

Code Enforcement Officer Jerry Parsons submitted the following emailed report:

- 1) 14 permits to date
- 2) Brock moved junk off property line so fence could be built on adjoining property on South Parkway.
- New company, TrailOtter is moving into one side of Elijah House and waiting on sign permit. The upstairs
 apartments are coming along.
- 4) 118 Main St.: Property keeps getting broken into. Sheriff Dept. has been advised and will be patrolling. DEC will be doing more soil testing. Mayor Briffa noted that FHLMC now owns the property through foreclosure and has offered the property to the Village through a National Community Stabilization Trust Donation Program for Municipalities for \$1.00. The Village Attorney and Engineers are now involved and will be reviewing all the documentation.

<u>PUBLIC COMMENTS:</u> There was question on the streetlights out on Oak Manor. Mayor Briffa noted that they have been called in and are supposed to be fixed and also noted that he is hoping to have all the Village lights converted to LED with the help of a grant program next year.

OLD BUSINESS:

Community Building: Mayor Briffa reported that AB Cole Realty was supposed to be at this meeting to give an update. He noted that ARC is still interested and that there is a new entity interested but there is no information on who the entity is. Mayor Briffa noted that Hannah Realty, based in Greece, is interested in listing the property but feels the property should be listed for sale. Trustee Constantino noted he has another realtor that is interested in listing the property and will get Clerk-Treasurer DeGraff the contact information.

NEW BUSINESS:

Forestry Grant: Mayor Briffa noted that we need bids from an arborist prior to submitting.

MAYOR'S REPORT:

Main Street Trees: Clerk-Treasurer DeGraff presented the only quote from Andy Koziel for \$2800 to take down 2 trees at Kane house on Main Street in Villages R.O.W. Trustee Jacobs, motioned, 2nd by Trustee Rizzo to accept the quote [Motion Carried 3-0]

Shared Services Grant: \$1000 is coming from Livingston County

CLERK'S REPORT:

Winter Wonderland Ad: After some discussion, it was agreed to continue with placing a separate ad in the Mt Morris Shopper for the Winter Wonderland.

Sexual Harassment Policy: Trustee Constantino motioned, 2nd by Trustee Rizzo, to adopt the Sexual Harassment Policy for All Employers in New York State 10/19 Version as presented. [Motion Carried 3-0] Clerk-Treasurer DeGraff noted that the Village Board and employees completed Sexual Harassment Prevention Training and that she will be scheduling the training for the Fire Department next.

NYSEG Energy Lighting Audit: Clerk-Treasurer DeGraff noted that there was an amendment to the Community Building proposal (Village Cost originally quoted \$13,882.25 decreased to \$11,682.25). She also noted that Tim Howe went to the Fire Hall but failed to provide a quote to upgrade the lighting necessary in the basement in time for the meeting. After some discussion Trustee Constantino motioned, 2¹³ by Trustee Jacobs, to go ahead with NYSEG to update the entire Fire Hall at a cost to the Village of \$1,701.48 [Motion Carried 3-0]

Trustee Rizzo motioned, 2nd by Trustee Constantino, to accept the bills as audited [Motion Carried 3-0] General Fund Vouchers 1860-1876 \$3,763.10 Water Fund Vouchers 713-718 \$2950.43
