COMMITTEE REPORTS:

Fire Company Report:

Fire Chief Jim Kane reported the following:

- 1) The department was called out 4 times with 67 calls YTD (See attached report)
- 2) SCBA Fit Test and Sexual Harassment Training has been completed.
- 3) 3x5 American Flag is torn. Mayor Briffa authorized the purchase of a new one.
- 4) Leicester Boy Scout Troop 85 Requested the use of the Fire Hall on February 1* & 2** for Movie night; May 25th for Memorial Day Pancake Breakfast and July 11th for the Annual Pop Can Drive which was approved on a motion by Trustee Constantino, 2nd by Trustee Frantz [Motion Carried 4-0].

Highway Superintendent Report:

Mayor Briffa reported on behalf of Highway Superintendent Russ Page that the water main break on Mahoney Street on November 27th was repaired quickly.

Water Report:

Mayor Briffa reported on behalf of Water Operator Al Mothershed that the Health Report questioned Al's license grade qualifications for the first time and it will be researched. The Village will be working on a Comprehensive Plan and researching grant opportunities for a Generator at the Pump House.

Zoning/Code Enforcement Report:

Mayor Briffa reported on behalf of Code Enforcement Officer Jerry Parsons on the status of 118 Main Street with respect to trespassing and the Sheriff's Department patrolling the property. Mayor Briffa also noted that the Brokerage company has indicated that FHLMC is working with DEC to clean up the soil contamination on the property. The Village Attorney is reviewing all documentation and advising before pursuing any acquisition through the National Community Stabilization Trust Donation Program for Municipalities for \$1.00.

PUBLIC COMMENTS: It was noted that there is a pole light out on South Street near Main Street.
